# MEMORANDUM OF AGREEMENT Between LAWRENCE TECHNOLOGICAL UNIVERSITY and CIHAN UNIVERSITY

Both Universities are represented by Global Schooling Systems LLC. And its president Dr. Nadera Nassif by its authorization pertaining all activities drafted between LTU and UOS

Lawrence Technological University (hereafter abbreviated as LTU), having its campus at 21000 West Ten Mile Road, Southfield, MI, USA, and Cihan University (hereafter abbreviated as CU) for the purpose of cooperation, agree to the terms of this Memorandum of Agreement.

Both institutions are committed to higher education, international understanding and academic growth through intercultural education.

# Purpose of the Program

This program of cooperation has several components:

- a) Student Exchange between CU and LTU
- b) Undergraduate student study abroad program between CU and LTU
- c) Summer Student Program
- d) Faculty exchange
- e) Faculty Development Programs
- f) Joint delivery of master's programs
- g) Joint delivery of Architecture and Media Communication Studios
- f) Joint submission of proposals for collaborating projects

h) Joint organization of national and international conferences

### Student Exchange Program

Students from both universities in majors offered at both universities will be eligible to participate in a student exchange programs. Students will be responsible for living and traveling expenses when participating in the exchange program.

#### Summer Student Program

Students from CU will come to LTU in the summer as guest students for a program developed between LTU and CU They will participate in a cultural program and in student projects with LTU faculty. Students will pay LTU the fee established for the summer program.

## Faculty Exchange

The two universities will exchange faculty in the areas of common interest including Communication, English, Architecture, and Management. The exchange of faculty will facilitate collaboration among faculty in student projects and other scholarly activities.

#### Joint delivery of master's programs

LTU and CU will explore the opportunity of offering jointly master's programs in areas of common interest to both universities.

The collaborative program may require approval from the appropriate Kurdistan Regional Government Ministry of Higher Education.

Joint delivery of Media Communication and Architecture Studios

Faculty members at both universities will identify media communication and architecture studios that will be taught jointly at CU and LTU

Joint submission of proposals for collaborating projects

Both institutions will identify joint projects and will find sources to apply for funds

# Joint Organization of National and International Conferences

Faculty from CU and LTU will work together in the joint organization of international conferences appropriate for the expertise in both universities. The theme of these conferences will be identified at a later date in discussions with CU and LTU.

#### Review

This co-operation agreement is subject to review three years from the date of this agreement and the agreement may be canceled if either side is not satisfied with the result of the co-operation. However, both sides shall honor their commitments prior to termination.

The present agreement will become effective from signature's date, and will have duration of five years. This agreement may be extended only with written approval

of the competent academic bodies and after evaluation of carried out activities.
